

AT THE THRESHOLD I

Refund and Cancellation Policy

September 4–7, 2026 · Plantation, Florida

1. Parties to This Agreement

This agreement is entered into between Cosmopolitan Healing Center LLC, a Florida limited liability company owned and operated by Dr. Carmen Jiménez, DAHM ("Host," "we," or "us"), which operates the venue at which At the Threshold I (the "Program") takes place, and the individual registering for the Program ("Participant," "you"). The Program is facilitated by Dr. Trice Mikulic, DACM, of Global Meditation Solutions ("Facilitator"), who is engaged by the Host to design and lead the Program content. References to "the Program" throughout this document refer collectively to the venue, facilitation, instruction, and all related activities offered as part of At the Threshold I.

2. Deposits Are Non-Refundable

All Participants are required to pay a non-refundable deposit of three-hundred dollars (\$300) to reserve their place in the Program. This deposit is non-refundable under all circumstances, including cancellation by the participant, failure to complete payment of the remaining balance, or inability to attend for any reason.

The deposit compensates Cosmopolitan Healing Center LLC and Global Meditation Solutions for the reservation of a place in an intentionally limited group, and for planning, preparation, and administrative costs incurred from the date of registration.

3. Cancellation by Participant

Before August 14, 2026: Participants who cancel before August 14, 2026 are eligible for a refund of amounts paid beyond the non-refundable deposit. The \$300 deposit is retained in all cases and is not refunded.

On or after August 14, 2026: Participants who cancel on or after August 14, 2026 are not eligible for any refund. All amounts paid, including any balance paid beyond the deposit, are forfeited. No exceptions will be made.

In all cases: Cancellations must be submitted in writing to drtrice@gmeditationsolutions.com. Verbal cancellations are not accepted. The cancellation date is the date the written notice is sent.

4. Cancellation or Rescheduling by Host or Facilitator

The Host and Facilitator reserve the right to cancel or reschedule the Program due to unforeseen circumstances, insufficient enrollment, illness, emergency, or other events beyond reasonable control.

If the Program is canceled, participants will receive a full refund of all payments made, including the deposit.

If the Program is rescheduled, participants may choose either to transfer their registration to the new training dates or request a full refund.

Please note that refunds apply only to payments made directly toward the Program and do not include reimbursement for travel, lodging, or other personal expenses.

5. Transfer of Registration

You may request to transfer your registration to another individual at any time before August 14, 2026. To initiate a transfer, notify us in writing (drtrice@gmeditationsolutions.com) with the name and contact details of the person you wish to transfer to.

A transfer is not complete until all four (4) of the following have been satisfied by the incoming participant:

- the application has been submitted and accepted
- the Participant Agreement and Liability Waiver has been signed
- the Terms and Conditions and Refund and Cancellation Policy are signed
- any outstanding balance on the original registration has been paid in full

We reserve the right to decline a transfer if the incoming participant does not meet our participation criteria.

6. Payment Plan Terms

Your deposit (\$300) is due at the time of registration and is non-refundable. The remaining balance is due no later than August 6, 2026. If the balance is not received by this date, your place in the Program may be released, at our discretion, and processed as a cancellation.

7. Early Bird Pricing

Early Bird pricing (\$1,097) is available **only** to the first four (4) participants who complete payment in full. It is not available through a deposit.

8. Travel Arrangements

We are not responsible for any costs you incur related to travel, flights, or lodging booked in connection with the Program. We recommend considering travel insurance, before booking non-refundable travel.

9. Entire Agreement

This Agreement, together with the Terms and Conditions, Participant Agreement and Liability Waiver, and the Program Questionnaire, constitutes the entire agreement between Participant, Facilitator and Host regarding the Program, and supersedes any prior understandings or representations, whether written or oral. Host and Facilitator reserve the right to update these terms prior to the Program start date, with notice provided to all registered Participants.
